The Bossier Parish Police Jury met in regular and legal session on the 18th day of April, 2018, at 2:00 p.m., in the Police Jury Meeting Room, Bossier Parish Courthouse, Benton, Louisiana. The President, Mr. Glenn Benton, called the meeting to order. The invocation was given by Mr. Mac Plummer, and the pledge of allegiance was led by Mr. Freddy Shewmake. The Parish Secretary, Ms. Rachel Hauser, called the roll, with all members present, as follows:

Others present were Mr. William R. Altimus, Parish Administrator; Mr. Joe E. "Butch" Ford, Jr., Parish Engineer; Ms. Rachel Hauser, Parish Secretary.

Motion was made by Mr. Shewmake, seconded by Mr. Darby, to adopt the minutes of the March 7, 2018, and March 21, 2018, regular meetings, and the March 21, 2018, Finance Committee meeting, as published.

The President called for public comment. There being none, votes were cast and the motion carried unanimously.

Motion was made by Mr. Brotherton, seconded by Mr. Rimmer, to schedule a public hearing on May 16, 2018, to consider approval of the plat of the proposed development of Dogwood South Subdivision, Unit No. 3-B, being a resubdivision of a portion of Lot 94, Dogwood South Subdivision, Unit No. 3-A, located in Section 8, Township 18 North, Range 12 West, Bossier Parish, LA.

The President called for public comment. There being none, votes were cast and the motion carried unanimously.

Mr. David Ghormley, Property Standards Officer, presented photographs of the property located at 210 Longhorn Drive, Bossier City, LA, Tax Assessment No. 111585, advising that the property owners have complied with all requests made to clean up the property, and recommended that the file pertaining to property standards be closed.

Motion was made by Ms. Bennett, seconded by Mr. Brotherton, to dismiss condemnation proceedings on property at 210 Longhorn Drive, Bossier City, LA, Tax Assessment No. 111585.

The President called for public comment. There being none, votes were cast and the motion carried unanimously.

Ms. Hauser reported that the meeting of the Property Standards Board of Review scheduled today was cancelled.

Mr. Bob Brotherton, Chairman of the Road/Subdivision Regulations Committee, reported on a meeting of that committee. Committee members attending the Road/Subdivision Regulations Committee meeting were Mr. Brotherton, Mr. Plummer, Ms. Bennett, Mr. Craig, Mr. Rimmer, and Mr. Shewmake. Mr. Jackson, Mr. Ford, Mr. Jim Viola, Mr. John Viola, Mr. Josh Walker, Mr. Brandon Aillet, Mr. Tim Wright, Mr. Sam Marsiglia, and Ms. Carlotta Askew-Brown were also present. Other jurors present were Mr. Darby and Mr. Salzer.

Mr. Brotherton reported that the committee discussed safety projects for Bossier Parish roadways. He stated that a report has been made available that provides information of all accident on roadways statewide, and Bossier Parish will be participating in the program to make Bossier Parish roadways safer. He further stated that workshops will be held quarterly to further discuss the creation of a plan to improve roadway safety.

Mr. Brotherton stated that straightening curves on parish roadways, widening roadways, ensuring that all road signs are visible during the day and night, and improving road striping are just a few ways to improve road safety.

Mr. Brotherton stated that the committee also discussed the creation of a plan by the levee board to inspect levees regularly to ensure that the levees remain intact during flood events. He further stated that Bossier Parish levees received a safety rating of three out of five, and during the last several flood events, the levees have held the water on the Red River side of the levee as it was created to do. Mr. Brotherton stated that additional reports are expected pertaining to the levees.

Mr. Brotherton stated that the committee also discussed drainage issues at Cash Point. Mr. Ford stated that drainage issues at Cash Point have evolved over a period of 15 to 20 years. He stated that the original land owner developed property, and subsequently sold the properties. Mr. Ford stated that before selling the properties, the previous landowner blocked the natural drainage creating drainage issues in this area.

Mr. Ford stated that an outfall pipe located beneath the railroad track at LA Highway 3 near Cash Point Road allows some relief from flooding on the west side of the railroad track. He stated that Mr. Jim Viola attended the Road/Subdivision Regulations Committee to address the drainage issues at Cash Point. Mr. Ford stated that once he is able to confirm that no properties located downstream in the lateral will be adversely affected, a ditch approximately 400 feet long and 15 inches deep will be created to provide some relief to property owners on the west side of the railroad tracks at Cash Point Road.

Mr. Ford stated that in the future if a request is received for any type of development on property on the west side of the railroad tracks at Cash Point Road, they will be required to improve the drainage and be responsible for all costs associated with those improvements.

Mr. Mac Plummer, Chairman of the Parks and Recreation Committee, reported on a meeting of that committee. Committee members attending the Parks and Recreation Committee meeting were Mr. Plummer, Mr. Shewmake, Mr. Brotherton, Mr. Salzer, and Mr. Benton. Mr. Altimus, Mr. Ford, Mr. Jim Viola, Mr. John Viola, Mr. Jackson, Mr. Warren Saucier, Mr. Brandon Aillet, Mr. Josh Walker, Mr. Tim Wright, and Ms. Carlotta Askew-Brown were also present. Other Jurors present were Mr. Darby, Mr. Rimmer, Mr. Craig, and Ms. Bennett.

Mr. Plummer stated that the Parks and Recreation Committee discussed the purchase of an 18-acre tract of land contiguous to Parish Camp in order to expand Parish Camp. He stated that an appraisal has been done on the property, and the committee recommends that Mr. Altimus and Mr. Ford be authorized to proceed with the purchase of the property.

Motion was made by Mr. Plummer, seconded by Mr. Cochran, to authorize the purchase of an 18-acre tract of land contiguous to Parish Camp located in Section 18, Township 16 North, Range 10 West, Bossier Parish, LA, for the expansion of Parish Camp, and to authorize the execution of documents.

The President called for public comment. There being none, votes were cast and the motion carried unanimously.

Mr. Rocky Rockett, Greater Bossier Economic Development Foundation, stated that Axis Construction would like to expand their business and purchase a 5-acre tract of land in Viking Drive Industrial Park at \$55,000.00 per acre. He further stated that the expansion of Axis Construction will create up to 15 additional jobs in 18 months, and it is anticipated that Axis Construction will be spending approximately \$700,000.00 for infrastructure and a facility. He stated that Hydroline, LLC, is a large company that provides water work for frac companies in the area. Mr. Rockett stated that Hydroline, LLC, currently employs approximately 50 employees, and plans to expand and add an additional 90 employees in the next 18 months. He further stated that Hydroline, LLC, plans to make a \$2 million to \$2.5 million investment in infrastructure and a facility.

Mr. Rockett stated that the agreement will include a clawback clause, giving the police jury first option to purchase the property back from Hydroline, LLC, if they decide not to construct the facility.

Mr. Altimus reported that a special meeting of the Bond Commission will possibly be held on April 26, 2018, to discuss the Grant Anticipation Revenue Vehicles (GARVEE) Bond which pertains to the new entrance gate off I-20/I-220 into Barksdale Air Force Base project. He stated that he will provide information to the police jurors as it becomes available to him.

Mr. Ford stated that contracts have been executed for State Project No. H.003854/H.011726, F.A.P. No. H.003854/H.011726, Bossier North/South Corridor, I-220/Swan Lake Road Interchange to Crouch Road, Bossier Parish, LA. He stated that it is anticipated that the project will begin in the next few weeks.

Mr. Ford reported that he has received 75 to 80 calls pertaining to drainage issues due to the recent rain events. He stated that these complaints are being dealt with as quickly as possible, and requested that if the police jurors receive calls for drainage complaints, the callers be directed to contact the engineering department.

Mr. Benton stated that grates in Country Place Subdivision were damaged during the recent storm event, and requested that the grates be replaced as soon as possible.

Mr. Mark Coutee, Public Works Director, presented an update on activities of the highway department and on several road projects in the parish. He reported that highway crews hauled off forty 12-yard truckloads of debris yesterday from the recent storm throughout the parish. He stated that he anticipates that storm cleanup will continue for at least one additional week.

Mr. Benton expressed appreciation to Mr. Coutee and highway department crews for their quick response in helping Bossier Parish citizens during and after the recent storms.

Ms. Bennett requested that Mr. Coutee extend the police jury's appreciation to the highway department crews for their assistance to the citizens during and after the recent storms.

Mr. Warren Saucier, Parks and Recreation Director, presented an update on activities at parks throughout Bossier Parish. He stated that crews are mowing daily.

Mr. Saucier stated that baseball season has begun at Lawson Bo Brandon Sports Complex, and the lacrosse season and soccer season has begun at South Bossier Park.

Mr. Saucier reported that STARBASE Louisiana, a premier Department of Defense STEM (science, technology, engineering, and mathematics) program for Bossier Parish students sponsored by the 307th Bomb Wing of the Air Force Reserve Command, recently used the South Bossier Park facilities to launch rockets.

Mr. Rimmer requested that an Industrial Development Committee meeting be scheduled on May 3,2018, time to be determined, to discuss upcoming projects in Bossier Parish and possible future abatement requests. He stated that Mr. Rockett will be present at the meeting.

Mr. Brotherton stated that Mr. Kelly Wells, Shreveport-Bossier Sports Commission, requested assistance from the police jurors by welcoming representatives from the Archery Shooter's Association (ASA) during their visit to tour a potential site for a 3-D archery competition. He stated that ASA hosts the largest archery competition in the United States, and Mr. Kelly has been working for the last seven years to bring the ASA archery tournament to the Shreveport/Bossier area.

Mr. Brotherton stated that the original site for the archery tournament was Clark Custom Guns in Haughton off Highway 80, and he immediately contacted the Mayor of Haughton to discuss this event. He stated that he and several jurors attended a meeting with ASA representatives and toured the Clark Custom Guns property. Mr. Brotherton stated that unfortunately due to all the recent rain events, much of the property was under water and could not be used for the 3-D archery tournament.

Mr. Brotherton stated that Camp Minden was recommended as a potential site for the tournament. He stated that Mr. Craig immediately contacted representatives at Camp Minden to request approval for the archery tournament to be held at Camp Minden. Mr. Brotherton stated that before the end of the day, Mr. Craig was able to schedule a meeting with Camp Minden personnel.

Mr. Brotherton stated that the meeting went well, and Camp Minden personnel stated that plans were already being made to begin an archery program due to the high volume of interest in archery. He stated that before the end of the day, Camp Minden had given approval for the ASA archery tournament to be held on Camp Minden property. Mr. Brotherton stated that representatives from ASA are scheduled to return in order to tour the Camp Minden site.

Mr. Brotherton expressed appreciation to everyone that worked diligently in finding another location in Bossier Parish for the ASA archery tournament, and stated that he will provide additional information as it becomes available to him. He stated that if ASA chooses Camp Minden as the site to hold the archery tournament, there will be approximately 2,000 to 2,500 visitors coming to the Shreveport/Bossier area for approximately five days. He further stated that this would create a potential \$1.5 million economic boost to the Shreveport/Bossier area.

Mr. Rimmer requested that the family of Carly Ortiz, a 2-year old little girl that was killed when a tree fell on her home during the Friday storm event, be remembered in everyone's thoughts and prayers. He expressed appreciation to Hillcrest Funeral Home for donating the funeral services for Carly.

Motion was made by Mr. Rimmer, seconded by Ms. Bennett, to approve payment of accounts payable invoices for the month of March, 2018.

Mr. Plummer called for public comment. There being none, votes were cast and the motion carried unanimously.

Motion was made by Mr. Brotherton, seconded by Mr. Salzer, to approve an expenditure of funds in the amount of \$5,000.00 from the General Fund for the 175^{th} Anniversary of Bossier Parish celebration.

Mr. Plummer called for public comment. There being none, votes were cast and the motion carried unanimously.

Mr. Darby expressed concern pertaining to the number of requests received by entities for police jury funds for events. Mr. Rimmer stated that it was understood when the police jury made a contribution last year to Bossier Parish Community College for assistance with costs for the Upstate Rising Conference event, the police jury would reduce the amount each year until there were enough sponsors to support the event without the need of police jury funds.

Mr. Brotherton stated that some police jury staff and police jurors actively participated in the conference last year, and the conference has a positive economic impact on the community.

After further discussion, motion was made by Mr. Rimmer, seconded by Mr. Cochran, to approve a request from Bossier Parish Community College for assistance with costs in the amount of \$2,500.00 for the Upstate Rising Conference event scheduled on August 23, 2018.

Mr. Plummer called for public comment. There being none, votes were cast and the motion carried unanimously.

The Finance Committee meeting was adjourned by the Chairman.
